5 LATE BIDS

5.1 Bids received late shall not be considered. A bid will be considered late if it arrives even one second after 11:00 or any time thereafter. The tender (bid) box shall be closed at exactly 11:00, and bids arriving late will not be considered under any circumstances. Bids received late shall be returned unopened to the bidder. Bidders are therefore strongly advised to ensure that bids are dispatched, allowing enough time for any unforeseen events that may delay the delivery of the bid.

5.2 The official Telkom time, which can be observed by dialing 1026 from any phone, will be used to verify the exact closing time.

5.3 Bids sent to the NEMISA via normal post, or any other mechanism shall be deemed to be received at the date and time of arrival at the NEMISA premises (tender/bid box or reception). Bids received at the physical address after the closing date and time of the bid, shall therefore be deemed to be received late.

6 PAYMENTS

6.1 NEMISA will pay the Contractor the fees set out in the final contract according to the table of deliverables. No additional amounts will be payable by the NEMISA to the Contractor.

6.1.1 The Contractor shall from time to time during the duration of the contract, invoice NEMISA for the services rendered.

- 6.1.2 The invoice must be accompanied by supporting source document(s) containing detailed information, as NEMISA may reasonably require, for the purposes of establishing the specific nature, extent and quality of the services which were undertaken by the Contractor.
- 6.1.3 No payment will be made to the Contractor unless an original tax invoice complying with section 20 of the VAT Act No 89 of 1991, as amended, has been submitted to NEMISA.
- 6.1.4 Payment shall be made by bank transfer into the Contractor's back account normally 30 days after receipt of an acceptable, original, valid tax invoice. Money will only be transferred into a South African bank account. (Banking details must be submitted as soon as the bid is awarded).
- 6.2 The Contractor shall be responsible for accounting to the appropriate authorities for its income tax, VAT or other moneys required to be paid in terms of the applicable law.

TERMS OF REFERENCE (TOR)

PROVISION OF INTERNE, FIREWALL, AND VIRTUAL PRIVATE NETWORK(VPN) SERVICES VIA AN SD-WAN FOR A PERIOD OF 3 YEARS

1. BACKGROUND

NEMISA was established as a non-profit educational institute under the Companies Act of 1973 and is classified as a Schedule 3A public entity under the Public Finance Management Act of 1999. It operates under the mandate of the Department of Communications and Digital Technologies (DCDT), which was formed after the merger of the Department of Telecommunications and Postal Services (DTPS) and the Department of Communications (DOC).

NEMISA's Auckland Park office has a 200 Mbps fiber connection, along with a 200 Mbps wireless failover link. A cross-connect VPN link connects the Auckland Park office to a data centre, allowing access to its cloud-hosted server infrastructure.

2. PURPOSE

The National Electronic Media Institute of South Africa (NEMISA) invites suitably qualified Internet Service Providers (ISPs) to submit proposals for the provision of Internet, Firewall, and Virtual Private Network (VPN) services via an SD-WAN. The successful bidder will be responsible for delivering a highly reliable, secure and managed service, in accordance with industry best practice, relevant legislation, and established frameworks.

REQUIREMENTS FOR THE PROPOSAL

NEMISA requires a 36-month contract for Internet services. The minimum specifications for the solution are as follows:

REQUIREMENTS

Fibre Connection

A dedicated business-grade uncapped last-mile fibre connection with a guaranteed bandwidth of at least 200 Mbps.

Cross VPN Connection

A secure cross-connect between NEMISA and the Data Centre at 10 Mbps, ensuring connectivity to cloud-hosted servers (IaaS).

Failover Link

An advanced LTE or microwave failover link capable of delivering at least 200 Mbps.

Firewall

The ISP shall implement a Next-Generation Firewall (NGFW) incorporating application-layer filtering, intrusion prevention (IPS/IDS), SSL decryption, and AI-driven threat intelligence for adaptive security. Traffic management capabilities must include dynamic shaping, failover redundancy, cloud firewall compatibility, and quality of service policies ensuring bandwidth prioritisation for critical applications that will:

- Enforce least privilege access, maintaining detailed audit logs, automating security policy enforcement and undergoing regular assessments.
- Support network segmentation, deep packet inspection (DPI), zero-trust authentication, and real-time intrusion detection to enhance security posture.
- Provide robust encryption for data transmission, secure authentication mechanisms, proactive breach detection, and VPN-enforced secure access.

24/7 Technical Support

Connectivity and Monitoring:

Maintain end-to-end connectivity in line with the Service Level Agreement (SLA) and provide access to real-time monitoring of link status, uptime, downtime, capacity, and utilisation through a web portal or authorised application.

Root Cause Analysis and Post-Incident Analysis:

For all performance and availability issues, a formal root cause analysis must be delivered within five days of the incident. This analysis should include an explanation of the cause along with a remedial action plan: a process for conducting root cause analysis for major incidents to prevent recurrence, with documented corrective actions and continuous improvement initiatives.

Demonstration and Compliance:

The bidder must demonstrate the performance of all links during commissioning and throughout the service period. All required equipment and services, which may not be explicitly mentioned in the document, should be supplied to ensure completeness, operability, maintainability, and upgradeability.

Support Desk:

A 24-hour support desk, accessible via email and telephone, is mandatory.

Incident Logging:

A comprehensive system and process for logging all incidents, detailing the time of occurrence, reported symptoms, affected services, and initial diagnostic information. The logging process must ensure clear traceability and accessibility

for reporting and auditing purposes.

Resolution Timelines:

Adherence to pre-defined and contractually agreed-upon Service Level Agreements (SLAs) for incident resolution, categorised by severity. This includes clearly documented escalation paths and communication protocols for prolonged incidents.

Training and Documentation

The ISP will provide a comprehensive training program for NEMISA's IT staff to ensure they are fully equipped to manage and maintain the new services. This training will cover all aspects of the Internet and VPN services, including troubleshooting and support. Additionally, the ISP will provide detailed documentation, including user manuals, technical guides, and troubleshooting procedures.

Quality of Service

The service must offer efficient end-to-end Quality of Service (QoS) from the NEMISA head office through the ISP's network to cloud-hosted services (IaaS and VoIP). The QoS must be dynamically flexible so that, in the absence of voice traffic, data traffic may utilise the full available bandwidth.

Hardware and Installation**Ownership & Maintenance**

The bidder shall retain ownership, be responsible for the maintenance and upkeep of all supplied equipment and arrange the necessary insurance for equipment installed at NEMISA premises, all at no cost to NEMISA. Any rectification or replacement of faulty equipment is the bidder's responsibility without extra charges.

Civil Works

The bidder is also required to perform all necessary civil works related to the installation and commissioning of the required links. Should any damage occur to NEMISA or third-party property during installation, the bidder must rectify or replace the damaged property at its own cost and provide appropriate compensation if necessary.

VLAN Segmentation, Network Management, and SD-WAN Configurations**Multi-VLAN Support**

The proposed solution must support the configuration and management of multiple Virtual Local Area Networks (VLANs) to segregate traffic for distinct user groups, including but not limited to guests, students, and staff. This segmentation is critical for enforcing tailored security policies, ensuring Quality of Service, and optimising network performance.

Configuration and Policy Control

The solution should allow NEMISA ICT administrators to define and modify policies per VLAN, including access control rules, bandwidth management, and security protocols. This ensures that guest access does not interfere with the performance or security of networks used by students and staff.

Scalability and Flexibility

The system should be scalable to allow future expansion or the addition of further VLANs as required by NEMISA's evolving business needs. Provision must be made for straightforward configuration changes without the need for vendor-specific interventions.

Scalability

The bidder is responsible for upgrading any hardware, software or firmware as part of the solution at no additional cost to NEMISA—this includes patching any vulnerabilities. The proposed solution must allow for downgrading, upgrading, or cancellation of certain services as business requirements change.

Reporting and Security

The ISP must implement industry best practice security standards on all links, including disabling any unused ports and

providing vulnerability and availability reports. A defined change control process must be incorporated in the proposal. The bidder must supply monthly reports containing daily traffic analysis and performance details for each link.

SCOPE OF WORK

The appointed ISP will provide fully managed TCP/IP Internet services for the NEMISA offices situated at:

26 Canary Street, Auckland Park (Gate 13)

GPS Coordinates: -26.188560, 28.010609

The service is expected to be highly available and reliable, with an overall uptime of no less than **99.5%**. The deliverables include, but are not limited to, the following:

MANAGED SERVICE DELIVERY

Provision of managed Internet services for a 36-month period, including a detailed proposal comprising a project plan, specifications, and pricing.

CONNECTIVITY

Installation of a dedicated fibre optic connection with a minimum bandwidth of 200 Mbps and an associated backup route, primarily for collaborations, web browsing, email access, research, VoIP and video conferencing.

VPN AND ADDITIONAL SERVICES

Provision of a secure VPN connection between NEMISA and the Data Centre (with rack details provided on appointment), implementation of QoS/VoIP, and support/maintenance documentation including an SLA.

TECHNICAL SUPPORT TRAINING

The bidder shall train NEMISA's IT staff, provide ongoing network monitoring, and supply fully licensed hardware and software where required.

PRICING

The pricing structure should be fixed to avoid any additional charges based on traffic or usage. It must encompass installation, insurance, maintenance, and any potential increases due to the Consumer Price Index (CPI). Monthly payments should remain constant for a period of 36 months. The total tender amount must include all of these costs, and no additional payments will be made outside of the submitted amount.

INFRASTRUCTURE AND STANDARDS

Supply all related hardware, cabling, and software. All installation costs are to be included in the submission. Industry standards must be adhered to, including compulsory ICASA registration, and a firewall solution must be proposed.

NOTIFICATION OF PLANNED DOWNTIME

Any planned downtime must be communicated in advance to the NEMISA IT department.

SCALABILITY

The solution must be sufficiently flexible to evolve alongside changing business requirements.

RISK MANAGEMENT

To ensure the successful implementation and operation of the Internet and VPN services, a comprehensive risk management plan will be developed. This plan will include the identification, assessment, and mitigation of potential risks. Key risks to be considered include service disruptions, security breaches, and compliance issues. The ISP will be required to provide a detailed risk management strategy as part of their proposal.

SERVICE LEVEL AGREEMENT (SLA)

CALCULATION OF SLA

Each circuit must achieve a guaranteed uptime of 99.5% (calculated monthly). Should the achieved uptime fall below this threshold, the following penalties shall apply as a percentage of the total monthly payment:

Link Uptime	Penalty (% of monthly payment)
≥ 99%	0%
> 98% to < 99.5%	10%

PERFORMANCE METRICS

In addition to the Service Level Agreement (SLA) for uptime, the following performance metrics will be monitored to ensure the quality of service:

Latency: The time it takes for data to travel from one point to another in the network.

Packet Loss: The percentage of data packets that are lost during transmission.

Jitter: The variation in the time it takes for data packets to reach their destination.

The ISP will be required to meet or exceed the specified thresholds for these metrics.

RESOLUTION TIMELINES

The SLA should clearly define the different incident severity levels. It must specify distinct response and resolution times for each severity level, tailored to different customer types.

The ISP is required to establish clear, measurable SLAs that support these timeframes. Additionally, there should be regular communication with customers during outages and post-incident analyses to ensure continuous improvement.

TIMELINES

The ISP must be prepared to commence service immediately upon issuance of the purchase order or the signing of the SLA, whichever is earlier.

All deliverables must be completed, reviewed, and formally approved, with invoicing issued accordingly.

The service is expected to be implemented, installed and operational by 1 November 2025 at the specified location.

CHANGE MANAGEMENT

To manage changes to the network or services effectively, a change control process will be implemented. This process

will include the following steps:

Change Request: Submission of a formal change request detailing the proposed change.

Impact Assessment: Evaluation of the potential impact of the change on the network and services.

Approval: Review and approval of the change request by relevant stakeholders.

Implementation: Execution of the approved change.

Review: Post-implementation review to ensure the change has been successfully implemented and to identify any issues.

Subcontracting and Third-Party Management

The ISP must clearly outline its approach to subcontracting and the use of third-party service providers for any aspect of the internet service delivery, including but not limited to:

DISCLOSURE OF SUBCONTRACTORS:

The ISP must disclose any and all significant subcontractors or third-party service providers it intends to use for the provision of the services, including network infrastructure (FNOs), field support, and specialised technical services.

This disclosure should include the name of the subcontractor, the specific services they will provide, and their relevant certifications or licenses.

ACCOUNTABILITY AND RESPONSIBILITY:

The primary ISP remains fully and solely accountable and responsible for the performance, quality, and adherence to all agreed-upon Service Level Agreements (SLAs) and terms specified in this ToR, regardless of whether services are delivered directly or through a subcontractor.

Any failure by a subcontractor to meet the required standards or SLAs will be considered a failure of the primary ISP.

SERVICE LEVEL FLOW-DOWN:

The ISP must demonstrate that it has legally binding agreements and corresponding SLAs in place with its subcontractors that mirror or exceed the requirements set forth in this ToR and the main contract.

This ensures that the performance obligations, including incident response and resolution times, security standards, and quality of service, are effectively "flowed down" to all parties involved in service delivery.

QUALITY CONTROL AND OVERSIGHT:

The ISP must detail its processes for managing, monitoring, and evaluating the performance of its subcontractors to ensure consistent service quality. This includes:

- Regular performance reviews.
- Audits of compliance with technical and operational standards.
- Mechanisms for addressing subcontractor non-performance.
- Procedures for incident escalation involving subcontractors.

SECURITY AND COMPLIANCE:

- The ISP must ensure that all subcontractors adhere to the same stringent security protocols, data privacy regulations (e.g., POPIA in South Africa), and compliance standards as the primary ISP.
- Evidence of such compliance (e.g., security certifications, data processing agreements) may be required for significant subcontractors.

CHANGE MANAGEMENT FOR SUBCONTRACTORS:

Any significant change in key subcontractors, or the scope of services provided by a subcontractor, must be communicated to and approved by NEMISA in advance.

1.3.2 The score for functionality shall be calculated as follows:

- ☐ Each panel member shall award values for each individual criterion on a score sheet. 1.4.2 NEMISA has decided/may decide to have compulsory presentations made either by all bidders who have obtained at least **80%** of the marks for functionality, or by the bidders ranked first to a maximum of six, but not less than the three highest scoring bidders once the price and preference marks have been combined.

1.4.3 Presentations shall only affect the marks awarded for functionality. If NEMISA wishes to use presentations to discriminate between bidders, the evaluation criteria to be affected shall be determined in advance and due allowance made in the mark scheme and indicated in paragraph 1.2.1.

1.4.4 Points determined by the presentation will be awarded to each bidder by each member of the Bid Evaluation Committee and then an average calculated. Such score will be added to the original score for functionality.

1.4.5 A bidder will be disqualified if the combined score for functionality fails to meet the minimum threshold for functionality as per paragraph 1.341.

1.5 ELIMINATION OF PROPOSALS ON GROUNDS OF FUNCTIONALITY

1.5.1 Bids that score less than **80%** of the marks available for functionality will be eliminated from further consideration. Marks will therefore not be awarded for their cost proposals or for preference.

1.6 PRICE AND SCM EVALUATION CRITERIA POINTS

1.6.1 All remaining bids will be evaluated as follows:
