## **6 PAYMENTS**

- 6.1 NEMISA will pay the Contractor the fees set out in the final contract according to the table of deliverables. No additional amounts will be payable by the NEMISA to the Contractor.
- 6.1.1 The Contractor shall from time to time during the duration of the contract, invoice NEMISA for the services rendered.
- 6.1.2 The invoice must be accompanied by supporting source document(s) containing detailed information, as NEMISA may reasonably require, for the purposes of establishing the specific nature, extent and quality of the services which were undertaken by the Contractor.
- 6.1.3 No payment will be made to the Contractor unless an original tax invoice complying with section 20 of the VAT Act No 89 of 1991, as amended, has been submitted to NEMISA.
- 6.1.4 Payment shall be made by bank transfer into the Contractor's bank account normally 30 days after receipt of an acceptable, original, valid tax invoice. Money will only be transferred into a South African bank account. (Banking details must be submitted as soon as the bid is awarded).

## **SERVICE AND MAINTENANCE TERMS OF REFERENCE (TOR) FOR A THREE-YEAR PERIOD**

### **1. Purpose**

These Terms of Reference outline the scope, responsibilities, and procedures for the ongoing service and maintenance of broadcasting studio equipment supplied to the production studio room, sound booth, and On-Air studio room. The objective is to ensure the operational efficiency, longevity, and safety of the equipment listed in the asset studio's sound booth below.

### **2. Business Requirements**

- Preventative and corrective maintenance of all radio studio equipment across the production studio room, sound booth, and On-Air studio room.
- Repair or replacement of faulty parts after maintenance jobs, as and when required, including but not limited to microphones, arms, headphones, mixers, routers, audio interfaces, and control surfaces.
- Call-outs during emergency breakdowns and alarm alerts, with timely response to minimise class disruptions.
- Maintenance description must outline one-off service activities, inspections, testing, software updates, and system checks.
- A 3-year maintenance plan detailing service intervals, responsibilities, and escalation procedures.
- Company profile demonstrating experience in audio broadcast equipment maintenance, configuration, and support.
- Letter of Good Standing aligned with the scope of broadcast and ICT equipment maintenance, compliant with occupational health and safety standards.
- A comprehensive Safety File including risk assessments, safe work procedures, and compliance with broadcasting environment requirements.
- The scope of service and maintenance shall not be limited to audio equipment but shall also include video equipment servicing, maintenance, and replacement where necessary. In compliance with the Public Finance Management Act (PFMA), relevant Treasury Regulations, and National Treasury Practice Notes on procurement, the service provider will be required to either appoint a qualified technician or subcontract a NEMISA-approved service provider.

**1.2 COMPLIANCE WITH MINIMUM SPECIFICATION REQUIREMENTS**

All remaining bids will be assessed in terms of compliance with the minimum specification requirements.

Bids which do not comply with the minimum specification requirements will be eliminated from further consideration.

### **1.3 PRICE AND SCM EVALUATION CRITERIA**

1.3.1 All remaining bids will be evaluated as follows:

1.3.2 The 80/20 preference point system will be applied. Points for price and SCM evaluation criteria will be awarded .

1.3.3 If appropriate, implied contract price adjustments will be made to the cost proposals of all remaining bids.

1.3.4 The Evaluation Committee may recommend that the contract be awarded to the bidder obtaining the highest aggregate mark as determined by 1.3.4 or to a lower scoring bid on justifiable grounds.

### **1.4 ADJUDICATION OF BID**

1.4.1 The relevant award structure will consider the recommendations and make the final award. The successful bidder will usually be the service provider scoring the highest number of points or it may be a lower scoring bid on justifiable grounds or no award at all.
