## TERMS OF REFERENCE (TOR)

### Terms of Reference: Appointment of a Service Provider for the Supply and Engraving of Employee Recognition Awards.

#### 1. Background.

The National Electronic Media Institute of South Africa (NEMISA) was established as a non-profit institute for education in terms of the Companies Act (1973) and is listed as a schedule 3A public entity in terms of the Public Finance Management Act (1999). The institute's programs are structured to enhance the market readiness of students in broadcasting and digital technologies. Its mandate was expanded to include the development of South Africans' digital skills capacity.

#### 2. Purpose.

NEMISA requires a reputable service provider to supply engraved customized awards that reflect the organization's values and recognize employee achievements. All prices quoted must be VAT inclusive if VAT registered.

#### 3. Scope of Work.

The appointed service provider will be required to:

##### 3.1 Design and Production.

- Provide design options for employee recognition awards.
- Ensure designs align with the organisation's branding guidelines where applicable.
- Material: High-quality shape crystal awards
- Design: Modern and elegant, with a sturdy glass base
- Dimensions: Approximate size range of 22cm in height.

##### 3.2 Engraving Services.

- Provide professional engraving services including:
  - Employee name
  - Award category
  - Year of recognition
  - Organization name and logo
  - Custom wording provided by the organisation
- Engraving: Precision laser engraving for text and logos, with clear visibility.

##### 3.3 Supply and Delivery.

- Supply the agreed number of awards.
- Package awards appropriately to prevent damage.
- Deliver the awards at NEMISA office, within the agreed timeframe.

#### 4. Deliverables.

The service provider will be expected to deliver the following:

- 20 Engraved awards according to the approved specifications.
- Safe packaging and delivery of the awards.

**1.2 COMPLIANCE WITH MINIMUM SPECIFICATION REQUIREMENTS**

All remaining bids will be assessed in terms of compliance with the minimum specification requirements.

Bids which do not comply with the minimum specification requirements will be eliminated from further consideration.

**1.3 PRICE AND SCM EVALUATION CRITERIA**

1.3.1 All remaining bids will be evaluated as follows:

1.3.2 The 80/20 preference point system will be applied. Points for price and SCM evaluation criteria will be awarded.

1.3.3 If appropriate, implied contract price adjustments will be made to the cost proposals of all remaining bids.

1.3.4 The Evaluation Committee may recommend that the contract be awarded to the bidder obtaining the highest aggregate mark as determined by 1.3.4 or to a lower-scoring bid on justifiable grounds.

**1.4 ADJUDICATION OF BID**

1.4.1 The relevant award structure will consider the recommendations and make the final award. The successful bidder will usually be the service provider scoring the highest number of points or it may be a lower scoring bid on justifiable grounds or no award at all.
