5 LATE BIDS

6 PAYMENTS

- 6.1 NEMISA will pay the Contractor the fees set out in the final contract according to the table of deliverables. No additional amounts will be payable by the NEMISA to the Contractor.
- 6.1.1 The Contractor shall from time to time during the duration of the contract, invoice NEMISA for the services rendered.
- 6.1.2 The invoice must be accompanied by supporting source document(s) containing detailed information, as NEMISA may reasonably require, for the purposes of establishing the specific nature, extent and quality of the services which were undertaken by the Contractor.
- 6.1.3 No payment will be made to the Contractor unless an original tax invoice complying with section 20 of the VAT Act No 89 of 1991, as amended, has been submitted to NEMISA.

TERMS OF REFERENCE (TOR) PROVISION OF FUNDRAISER INITIATIVE.

1. Introduction

The National Electronic Media Institute of South Africa (NEMISA), a Schedule 3A public entity under the Department of Communications and Digital Technologies, is mandated to provide digital skills training, media innovation, and promote content creation across South Africa.

2. Objective

In line with its Resource Mobilisation Strategy, NEMISA seeks to establish a Fundraising Panel comprising experienced, results-driven freelance fundraisers to assist in securing diversified and sustainable funding for strategic programmes.

The appointed Fundraiser will operate under a hybrid model, combining a monthly service fee (retainer) with performance-based commissions. This structure ensures fundraisers receive predictable income while remaining incentivized to secure funding and partnerships.

The commission will be determined from proposals submitted by Freelance fundraisers and will not be imposed by NEMISA on service providers.

3. Purpose

The Fundraising initiative aims to:

- 3.1 Mobilise resources for NEMISA's programmes.
- 3.2 Identify and secure multi-year strategic funding.
- 3.3 Build strong relationships with donors, corporate social investment (CSI) partners, development agencies, and international funders.
- 3.4 Support the sustainability of NEMISA's platforms, projects, and training initiatives.

4. Types of Funding Available in South Africa for SOEs

Panel members will focus on unlocking a mix of **financial, in-kind, and strategic contributions**, including but not limited to:

4.1 Public Sector Funding

- 4.1.1 Government Grants– e.g., Departmental funding for targeted projects.
- 4.1.2 Sector Education and Training Authorities (SETA) Funding – e.g., training grants for digital skills.
- 4.1.3 Special Presidential or Department Initiatives – innovation, youth employment, and skills funds.
- 4.1.4 Municipal & Provincial Development Grants – targeted at community-based training and creative projects.

4.2 Private Sector Funding

- 4.2.1 Corporate Social Investment (CSI) Funds – aligned to education, technology access, and cultural preservation.
- 4.2.2 Enterprise & Supplier Development (ESD) Funding – for SMME and creative industry empowerment.
- 4.2.3 Technology Sponsorships – e.g., laptops, servers, cameras, data, other devices.
- 4.2.4 Discretionary Grants – from corporate or foundation boards.

4.3 International & Development Partner Funding

- 4.3.1 Donor Agencies & Embassies – supporting education, gender inclusion, and cultural exchange.
- 4.3.2 Multilateral Organisations – e.g., UNESCO, UNDP, World Bank.
- 4.3.3 Creative & Digital Innovation Funds – specific to African media and technology sectors.

4.4 Non-Monetary/In-Kind Support

- 4.4.1 Media Space – free or discounted advertising on platforms like SABC or community radio.
- 4.4.2 Technology & Software Licenses – LMS zero-rating, editing suites, streaming capacity.
- 4.4.3 Content Co-Productions – collaborative funding for film, TV, and digital series.

4.5 Fundraising Models

- 4.5.1 Project-Based Funding – linked to specific deliverables (e.g., training 300 students).
- 4.5.2 Event-Based Fundraising – gala events, festivals, hackathons.
- 4.5.3 Crowdfunding Campaigns – targeting niche audiences.
- 4.5.4 Specialised Campaigns – tailored high-value donor drives.

5. Scope of Work

Fundraisers will:

- 5.1 Identify Opportunities – conduct research and mapping of relevant funding prospects.
- 5.2 Lead on funding proposal development for priority concepts. This involves drafting a compelling project narrative that translates our work for a donor audience, as well as program activities and outcomes, and a logical framework or theory of change.
- 5.3 Donor Engagement – manage communication and relationship building with potential funders.
- 5.4 Partnership Alignment – ensure proposals align with funders' CSR or strategic priorities.
- 5.5 Reporting – maintain donor/funder pipeline and submit monthly progress reports.
- 5.6 Strategic Advisory – provide insight on trends and opportunities in local/international fundraising.
- 5.7 Project Packaging – support the design of bankable proposals for strategic initiatives.

2. Monthly Retainer (Cost of Service)

Each fundraiser will receive a fixed monthly payment to cover operational costs and provide financial stability.

- Retainer is independent of performance and ensures ongoing engagement.
- Suggested retainer calculation
 - Based on the expected workload (e.g., number of clients/partnerships managed) and standard industry rates based on experience and previous amounts raised.
 - A set amount per month per fundraiser, adjustable depending on scope.

3. Performance-Based Commission

- Commission is earned in addition to the retainer, based on successful funding secured or partnerships established.
- Commission rates can vary depending on the size or type of funding
 - 15% to 20% of total funds raised per deal is proposed.
- Commission is only paid once funds are confirmed and received, aligning incentives with results.

4. Reporting & Accountability

- Fundraisers submit a monthly progress report detailing leads, meetings, proposals, and expected closings.
- Performance metrics include:
 - Number of deals closed
 - Value of funding secured

- Number of new partnerships established

5. Integration with NEMISA’s Internal Business Development Panel

- Fundraisers collaborate with the internal panel to identify opportunities, leverage networks, and align with strategic priorities.
- Jointly reviewed metrics ensure transparency and fairness in commission calculations.

6. Payment Schedule:

- **Monthly retainer:** Paid at the start of each month.
- **Commission:** Paid within 30 days of confirmed funding received by NEMISA.

5. Deliverables

- Fundraising strategy and annual work plan.
- Monthly progress and pipeline reports.
- Minimum of 10 or agreed-upon number of proposals per quarter (as per SLA).
- Record of donor engagement and commitments secured.
- End-of-term report with recommendations.

7. Appointment & Contract Terms

- Duration: 12 months initial appointment, renewable based on performance and funding secured.
- Remuneration: Commission-based payment model, percentage to be defined in SLA.
- Funding Duration Targets:
 - Short-Term: once-off or annual funding.
 - Long-Term: multi-year (3–5 years) commitments.

8. Risk Management

Panel members must:

- Adhere strictly to PFMA, CIPC, SARS, and other legal requirements.
- Avoid conflicts of interest and fraudulent activity.
- Maintain transparency in donor engagement.
- Comply with NEMISA’s ethical fundraising guidelines.

9. Eligibility Requirements

Applicants must:

- Have a minimum of 3–5 years’ fundraising experience with proven track record.
- Demonstrate success in securing funding from multiple sources.
- Possess strong proposal writing and donor relations skills.
- Be a registered freelancer or legal entity with valid tax compliance status.
- Provide references from past fundraising projects.

Minimum Threshold for Functionality

- Bidders must achieve a minimum score of 80% to be considered for appointment to the panel.
- Only bidders meeting the minimum functionality threshold will be evaluated on commission percentage and contractual terms.

8.2. These quotations will be evaluated in terms of the NEMISA Supply Chain Management Policy, the Preferential Procurement Policy Framework Act and its associated Regulations, the 80/20 preference point system.

8.3. Payment is strictly on the basis of the delivered items and invoice.

8.4. Service providers must give a detailed cost breakdown for all applicable costs.

CONDITIONS OF CONTRACT

The successful service provider undertakes:

11.1. To treat all relevant and available data and/or information provided by NEMISA and its employees strictly confidential.

11.2. Not to discuss or make any information available to any member of the public, press or other service provider/consultant or any other unauthorised person(s) except as authorised by NEMISA.

11.3. Not to copy or duplicate any software or documentation for private use.

11.4. To give back to NEMISA all documentation, reports, programmes, etc, upon completion of the project.

11.5. General conditions of the bid, contracts and orders will be applicable in the execution of the contract.

11.6. Parking and travel between the prospective service provider's home/office and NEMISA will be borne by the Service Provider.

11.7. Failure to adhere to the above conditions will lead to the invalidation of the quotation.

11.8. NEMISA reserves the right to discontinue work on any element of the quotation at any given time in consultation with the CEO for reasons such as the quality of work delivered being poor or the service provider being unduly delayed in delivering of services.

11.9. Prepares and present to EXCO and Management team a project plan outline upon their appointment.

11.11. All data provided in reports must be anonymised and aggregated to protect employee confidentiality.

11.12. The Service Provider must ensure nationwide accessibility of services for remote or regional staff and students.

1.2 COMPLIANCE WITH MINIMUM SPECIFICATION REQUIREMENTS

All remaining bids will be assessed in terms of compliance with the minimum specification requirements.

Bids which do not comply with the minimum specification requirements will be eliminated from further consideration.

1.3 PRICE AND SCM EVALUATION CRITERIA

1.3.1 All remaining bids will be evaluated as follows:

1.3.2 The 80/20 preference point system will be applied. Points for price and SCM evaluation criteria will be awarded .

1.3.3 If appropriate, implied contract price adjustments will be made to the cost proposals of all remaining bids.

1.3.4 The Evaluation Committee may recommend that the contract be awarded to the bidder obtaining the highest aggregate mark as determined by 1.3.4 or to a lower scoring bid on justifiable grounds.

1.4 ADJUDICATION OF BID

- 1.4.1 The relevant award structure will consider the recommendations and make the final award. The successful bidder will usually be the service provider scoring the highest number of points or it may be a lower scoring bid on justifiable grounds or no award at all.
