## **TERMS OF REFERENCE**

### **Appointment of an Event Management Service Provider for the Supply for NEMISA EPRRP 2026**

#### **1. Background**

The National Electronic Media Institute of South Africa (NEMISA) was established as a non-profit institute for education in terms of the Companies Act (1973) and is listed as a schedule 3A public entity in terms of the Public Finance Management Act (1999). The institute's programmes are structured to enhance the market readiness of students in broadcasting and digital technologies. Its mandate was expanded to include the development of South Africans' digital skills capacity.

#### **2. Purpose**

The objective of this Terms of Reference is to appoint a competent Event Management service provider to plan, coordinate, and manage all aspects of the Employee Recognition Awards Gala, including venue sourcing, catering, décor, entertainment, and overall event execution.

#### **3. Scope of Work**

The appointed Event Planner will be responsible for providing end-to-end event management services, including but not limited to the following:

##### **3.1 Event Planning and Coordination**

- Develop a detailed event concept aligned with employee recognition objectives
- Provide an event theme and programme flow
- Develop a comprehensive event project plan and timelines
- Coordinate all service providers and logistics
- Provide onsite event management and coordination

##### **3.2 Venue Sourcing and Management**

- Source and propose suitable venues that align with the gala event requirements
- Ensure venue capacity accommodates the expected number of attendees
- Ensure venue includes stage, lighting, sound, and audiovisual requirements
- Manage venue booking and liaison
- Confirm parking availability and accessibility requirements

- Propose catering options (welcome drinks, starter, main course, dessert, beverages)

**1.2 COMPLIANCE WITH MINIMUM SPECIFICATION REQUIREMENTS**

All remaining bids will be assessed in terms of compliance with the minimum specification requirements.

Bids which do not comply with the minimum specification requirements will be eliminated from further consideration.

**1.3 PRICE AND SCM EVALUATION CRITERIA**

1.3.1 All remaining bids will be evaluated as follows:

1.3.2 The 80/20 preference point system will be applied. Points for price and SCM evaluation criteria will be awarded .

1.3.3 If appropriate, implied contract price adjustments will be made to the cost proposals of all remaining bids.

1.3.4 The Evaluation Committee may recommend that the contract be awarded to the bidder obtaining the highest aggregate mark as determined by 1.3.4 or to a lower scoring bid on justifiable grounds.

## **1.4 ADJUDICATION OF BID**

- 1.4.1 The relevant award structure will consider the recommendations and make the final award. The successful bidder will usually be the service provider scoring the highest number of points or it may be a lower scoring bid on justifiable grounds or no award at all.
